



During data collection & compilation phase members of the GPPFT will be divided into small groups of 5-7 persons to organise the neighbourhood meeting (Para Baithak) to discuss the essence of the people's planand objectives for preparation of GPDP. The schedule of Para Baithaks shall have to be shared with Sanghas / SHGs in advance so that their participation in planning process can be ensured. Collection of SDG-Theme wise data and mapping exercises like Social Mapping, Natural Resource Mapping, Seasonal Diagram, Timeline, Focused Group Discussion on different thematic issues may be organised in Para Baithak. Theme wise data to be digitised through **Banglar Para Baithak Portal** [URL: www. parabaithak.wbprd.gov.in].

Integration of Village Poverty Reduction Plans(VPRPs) into GPDP is essential. Village Poverty Reduction Plans (VPRPs) under WBSRLM shall have to be prepared as an integral part of GPDP. As representatives of Shangha of SHGs are there in the Upa-Samitis, members of SHGs are included in the GPPFT of Gram Panchayat, community mobilization is done through hamlet level meetings (Para Baithak) by the GPPFT, preparation of VPRPs will also be done simultaneously with the preparation of comprehensive GPDP. The effort should be taken to incorporate VPRPs in the GPDPs.

Necessary direction may kindly be given to all concerned and all attempts need to be taken in your district for successful implementation of the initiative for preparation of Panchayat Development Plans for the Financial Year 2023-24 in a time bound manner.
